1. Sign-in & Welcome

- a. Vote to approve September minutes \rightarrow Approved
- 2. Presentation by Stephanie Jennings, Senior Health Insurance Specialist (Columbia Health)
 - a. Stephanie Jennings came as part of an initiative to ask more students groups on campus about what they like or would like to change about the student health insurance. The feedback will go to senior leadership and will be used to formulate the 2019-2020 health insurance plane.
 - b. First question from Stephanie: Thinking about the student health insurance plan, or your own, what do you find most important?
 - i. Vision care is not sufficient.
 - ii. Several concerns voiced that care should be based on what the doctor thinks is important, not dependent on financial concerns. Students have been told that things such as long-term physical therapy as recommended by the doctor is not covered, so health needs are inhibited by financial reasons and not care needs. Similarly, reps recounted that after receiving treatment the doctors approved or they were told that it would be covered they were later told that it wasn't covered, resulting in high bills and appeals etc., a demoralising process when trying to focus on school. There is an overall lack of accountability within the Columbia system as patients are frequently misinformed, resulting in later unanticipated costs.
 - Stephanie responded that the student health insurance plan covers an unlimited in terms of number of visits, but when you go off campus the physical therapist is required to provide notes about progress and that might be the problem. Acknowledged the need to more clearly communicated policies to health services to prevent the dissemination of incorrect information and overall addressing a lack of clarity and miscommunication.
 - c. Second question from Stephanie: What appeals most to you when you're managing your health care costs? For example, would you prefer lower premium and out of pocket cost?
 - i. International student issues with understanding basic terms of American insurance systems.
 - ii. For MA students, cost of the premium is prohibitively high. Chose to go on Medicaid instead.

- iii. Keeping copays low is crucial for doctoral students, for most of whom the premium is covered.
- iv. Student health usually refers you to another place, which means you pay the copay most of the time when you're sick.
- v. Another thing that's great that contraception and IUDs are free that we would like to keep free.
- vi. Desire for dental care for doctoral students. It's \$300 for an appointment.
 - 1. Stephanie responded that's outside the scope of her purview, but would still take back to committee.
- vii. It would be better to get electronic referrals without having to wait for an appointment at student health.
- viii. It is incredibly difficult to get a referral for an in-network doctor.
- ix. Process of referrals incredibly difficult for students who live off-campus.

The Communications Chair therefore read her statement, but there was no Q&A. The other candidates were not present and did not notify the committee that they would be absent. Therefore their nominations were not considered.

i. Internet in UAH

 Following up from last Plenary Meeting: Spoke with Dean Alonso, free internet will be rolled out over the next 12-18 months as Columbia installs internet in all buildings. Only Columbia internet is free, there are no plans to reimburse private internet plans at this time.

8. Senators' Updates (Andrew, Mike, Sally)

- a. Mike and Sally not present.
- b. Working on loosening restrictions about sharing on Google Drive beyond Columbia community.

- c. Developed My Grants tool (<u>https://mygrants.columbia.edu/</u>) feeds in data from all sponsored projects mapped onto calendar year all PIs should know how much money they have through this new tool.
- d. Disabilities Committee working on integrating disabilities into Core and trying to see if Braille and ASL can be used to fulfill foreign language requirement; new student group for students with chronic diseases - undergrad focused but grads should also be able to join.
- e. Trying to get more IGB funding, especially from uptown campus. Looking to combine and share spaces from all campuses and to host more events that are open to the public.

9. New Business (Open Forum)

- Amelia Spooner (History PhD Rep) and Mia Cecily Florin-Sefton (English PhD Rep):
 "Proposal to retract and replace ASGC's informal neutrality policy vis-à-vis the Graduate Workers of Columbia (GWC-UAW)" → Approved
 - i. Link to Background Information and Approved Proposal
 - ii. Amelia and Mia passed out copies of the proposal and brought a rep from the Bargaining Committee to answer questions.
 - iii. Discussion/Q&A
 - 1. ASGC Executive Board affirmed that because nothing ASGC does is legally considered Collective Bargaining, retracting neutrality would not affect what ASGC does for students. However, neutrality was adopted in part to make sure that ASGC could fully support students who are not pro-Union. Reiterated that ASGC remains committed to representing all students, regardless of their stance on the union.
 - 2. The proposal accommodates this need in the language by affirming that ASGC and Union have different roles, but ASGC recognizes the democratic vote and therefore this other body (Union).
 - 3. Part of the rational of neutrality at the time was before elections, and GSAC board didn't want to influence the vote. Now that the vote has happened, up to Plenary to decide on ASGC's position.
 - 4. Union wants people who don't agree with union to come and voice their concerns. Union meetings open to absolutely everyone.
 - 5. Collective Bargaining is a legal term that ASGC cannot do. Key part of language in proposal. This is about collaborating between two very effective bodies, there is no logical way in which these two processes are contradictory.
 - 6. Question regarding initial Union vote turn out to understand just how many people are supportive of the Union. Please see Union website for
