### Minutes From September Plenary Approved (approved unanimously)

### Amendment to the ASGC Constitution and By-Laws (approved unanimously)

The Language in the ASGC Constitution and By-Laws have been amended: “good standing” has been replaced to “eligible/ineligible” or “active/inactive” in order to avoid confusion with GSAS’s use of the term “good standing.”

Art. III, Sect. 4: Failure of DRs to meet the tasks outlined in the By-Laws (Article III) will result in a <b>status of bad standing</b> for the respective department. Art. III, Sect. 5 A <b>department in bad standing</b> is ineligible to apply for ASGC funding.	An <b>inactive department</b> is ineligible to apply for ASGC funding.
Art. IV, Sect. 5: Only graduate students from <b>departments in good standing</b> and whom will be registered as a student for the entire term shall be considered for officer election to the Executive Board.	Only graduate students from <b>active departments</b> and who will be registered as a student for the entire term shall be considered for officer election to the Executive Board.
Art. VI, Sect. 1: Each GSAS PhD and GSAS Masters Program, <b>in good standing</b> , is entitled to one vote.	Each <b>active</b> GSAS PhD and Masters Program is entitled to one vote.
Art. VI, Sect. 3: <b>Departmental statuses of departments with responsive DRs or new DRs are reset at the beginning of the Fall and Spring semester to good standing.</b>	<b>The status of inactive departments with responsive DRs or new DRs is reset to active at the beginning of the Fall and Spring semester.</b>
Art. VIII, Sect. 6: A simple majority of departments <b>in good standing</b> shall constitute quorum except when voting on Constitution or Bylaw amendments, as outlined by Article VI, section 5. Once quorum is determined, the presiding Executive Board officer calls the meeting to begin.	A simple majority of <b>active</b> departments shall constitute a quorum except when voting on Constitution or Bylaw amendments, as outlined by Article VI, section 5. Once a quorum is determined, the presiding Executive Board officer calls the meeting to begin.
Art. IX, Sect. 1 Department Representatives can be selected by any of three methods, outlined below: 1. ### Student Group Recognition (Will Plews-Ogan, ASGC VP, Administration, [asgc.vpadministration@columbia.edu](mailto:asgc.vpadministration@columbia.edu))

Columbia Physics Graduate Council was approved unanimously.

The council, open to all students in the GSAS community, will be led by Andrew Liu, the current department representative for physics.

- The council was incorporated informally as a group, but there was insufficient funding for graduate students.
- The council will be inclusive to people of all backgrounds.
- The council will be partnering with Spectra, another physics organization for including minorities in physics.
- Questions and Answers from the floor:  
Q: What efforts will be taken to reach out to students interested in physics, but not studying physics?  
A: The co-chair Bárbara Santiago responded that they will coordinate with people from applied physics, geophysics, and other departments. Any students from other departments are more than welcome to attend the events, and the council wants to get the physics community to be more social.  
Q: How would a student join?  
A: Andrew referred to the Facebook page - [Columbia Physics Council](#), where events and updates are posted regularly. The mailing list will be available on the Facebook page as well.
- A representative suggested that the council change their name to reflect that the organization is a club, and not a governing body. ASGC made this recommendation officially.

### Advocacy Updates (Alex Cuadrado, ASGC President, [asgc.president@columbia.edu](mailto:asgc.president@columbia.edu))

- Columbia Residential:

- a. Some students have been double-paying ConEd for utilities, and the deans are contacting Columbia Residential to reimburse these students.
  - b. Some tenants have experienced power shutoffs. ASGC can anonymously inform the deans about any issues the students have, so please do not hesitate to [reach out!](#)
  - c. All but five of the buildings of Columbia Residential will have WiFi installed. The residents of the other five that will have to pay for Spectrum. However, the implementation is behind schedule on most buildings.
  - d. Columbia Residential reimburses \$25 to the students for the cost of the rent payment plan. The president, Alex Cuadrado ([asgc.president@columbia.edu](mailto:asgc.president@columbia.edu)), told the plenary to contact him if a student has not been reimbursed by the end of the semester. ASGC is requesting Columbia Financial Services to include this information on the website
  - e. Members believe that there should be a Columbia Residential Committee, similar to other student advisory committees, that meets with Columbia Residential regularly.. - ASGC will be working with ISSO to offer OPT workshops for International students. Some students have requested legal advice from ISSO, but it is not permitted by the law.

  - a. The bargaining committee will be submitting changes to the stipend. The representative requested students to submit comments to [gwc.bargaining@gmail.com](mailto:gwc.bargaining@gmail.com) by tomorrow afternoon, October 15. The next bargaining date is Friday, October 18, and then on Wednesday, October 23
  - b. There is also a new National Labor and Relations Board (NLRB) rule. It is unclear as to whether the framework agreement would still apply, but there is still an initiative to submit comments to NLRB. #### **New Business: Open Forum**

- Department of Art History  
There was a request for more support for MA students writing their theses. The GSAS Writing Studio was initially for PhD students working on their dissertations, but ASGC will discuss the issue during the meeting with the Deans. However, there is also a University Writing Center, located in 301 Philosophy across the Graduate Student Lounge, open to all students and faculty.
- It was brought ASGC's attention that people with degrees from abroad may be required to check their transcripts, ie. need to send sealed copies, but some universities are given the sealed copies. Unfortunately, Columbia only accepts sealed copies directly from the schools.
