- 1. Welcome (President)
  - a. Welcome to any new department reps joining us for the first time!
  - b. Upcoming ASGC Plenary Meetings (always on a Tuesday, 6:30 pm): December 15
- 2. Guests
  - a. David Austell (Director, ISSO) and Samantha Lu (Associate Director of International Students at ISSO)
    - i. The time of Covid 19 has been difficult especially for international students, both those abroad and those here at Columbia currently.
    - ii. ISSO is currently thinking of ways to continue to aid international students
    - iii. International student population has gone down 17% this year due to Covid 19
      - 1. Very saddening, but ISSO is committed to raising these numbers back up next year
      - 2. There are still 16,000+ current students and alumni to serve
    - iv. ISSO is still adjusting to working remotely and providing advisement online
      - 1. This online advisement will continue through spring 2021
    - v. New upgrades!
      - One goal since March was to have better email communication; they are switching to a new University supported system this week. We, as students, shouldn't technically see anything different. Their email address will be staying the same. Additional links will be provided to international students to get to the ISSO website and to enhance the website more generally
      - 2. Another goal since March was for ISSO to roll out a self service form in an appointment system. This should be out sometime in December (but after Thanksgiving at the earliest) to aid students in scheduling phone and Zoom meetings. This should be able to replace the in-person walk in services. The link to their calendar will also be on their website.
    - vi. ISSO is also working to add 3 additional advisors to the ISSO staff. They will be there for students to share their concerns and to increase communication.
    - vii. Please dialogue with ISSO if you have any questions or concerns
    - viii. Questions and Answers
      - 1. General Guidance for deadline for arrival into the U.S. (CPT OR OPT)
        - a. The Dept. of Homeland Security has not yet given any guideline for the spring semester. If we do not receive updated guidelines, we will follow the fall semester guidelines. The fall guidelines were For students that are arriving for the first time in spring 2021 may be under different guidelines.

- i. If you were a student full time for Fall 2020 and you will be registering full time for spring 2021, you should be eligible for CPT and OPT
- b. Students that are currently outside of the US should go and schedule their VISA appointment
- Why has the ISSO resisted or ignored calls from the international students' working group (ISWG) and others, notably law professor Elora Mukherjee (<u>EMukherjee@law.columbia.edu</u>) at Columbia Law school, to set up free legal assistance for international students?
  - a. David will follow up with the lawyer tomorrow
  - b. There should not be legal fees associated with the huge majority of students within Columbia. They try to steer students to pro-bono counsel.
- 3. Why has the ISSO resisted or ignored calls to set up a joint task force on international student issues with the grad union?
  - a. The way they are approaching this is more extensive. They are trying to develop an international student leadership council in February. They will work in two ways: work with reps from the student councils and work with specific international Student organizations. They will be able to get specific nationalities and school based information from students.
- 4. What is ISSO doing to join with progressive voices calling for ICE to be defunded and abolished, after everything that's happened?
  - a. They are not aware of these progressive voices or this call to action. They want more information as to what is going on.

- e. Arden Lee (Diversity, Equity, and Inclusion Chair: ga2448@columbia.edu) gave an update on our Diversity Initiative Grants. Please apply: Diversity Initiative Grant. There are no deadlines on applications. There has been one application so far; however, it is being held up because it is for an honorarium. The grant should be awarded soon. The executive board will be checking with GSAS administration to see if honorariums will be allowed to be funded. Additionally, Arden spoke about the Internal Bias reporting procedure. She will be speaking to them during a meeting very soon. The bias reporting is for more minor incidences. Arden also spoke to department representatives about the Columbia University Libraries and their harmful language in their catalog records.   - a. Health
    - i. Bhargav (asgc.vpexternalaffairs@columbia.edu): Graduate students have access to voluntary testing no more than once per week. There is still also randomized testing taking place. Please be sure to participate in the randomized testing if you are chosen for it. There are separate testing facilities for asymptomatic (rapid access testing) and symptomatic testing. In addition, be sure to get your Flu vaccine by October 30th (it is passed that initial deadline now) or prior to returning to campus. Please do this ASAP and upload the required documentation to your patient portal if you get the shot off campus.

  - a. Climate School Advocacy was discussed both by Roger Creel (rcc2167@columbia.edu) and Mike Ford (Humanities Senator: (mlf2191@columbia.edu).
